## INTERNATIONAL LAW

The programme will give all participants the opportunity to attend cutting-edge lectures on international and European business law. Delegates will appreciate the strong focus on common legal issues that arise in the most complex commercial cases across different borders. They will learn more about international transactions as well as lawyering across various jurisdictions. This programme is the only extensive summer programme in Oxford that focuses on international law. The following courses have been offered in International Law in previous years:

### Legal Theory and Intellectual Property Rights

This course has been designed with the objective to provide students with various insights into international business law systems that govern international trade and commerce.

### International Taxation

The course will introduce the key concepts in taxation bringing an in-depth understanding of tax laws affecting international business and individuals.

### European Business Law

This course covers the main points of the European Union legal system and its interactions with member states' local laws in order to gain a perspective on Europe as a whole and its global influence.

### International Environmental Law

This course introduces students to international environmental law and to consider how international law may be used to enhance environmental protection.

### United Kingdom Contract & Corporate Law

This course will provide important legal aspects of international mergers and acquisitions. As many international contacts are governed by UK, US, or Hong Kong law, it is important for students to learn about these aspects of Common Law.

### International Criminal Law - Business-related Cases

This course aims to improve the participants' understanding of international criminal law for business-related cases and develop their critical abilities in that context.

### International Cyber Law

The course will present a general introduction to the most relevant topics ranging from internet governance and regulation, electronic contracting, information security, privacy, regulation of internet content and copyright.



## INTERNATIONAL ECONOMICS

The programme will give all participants the opportunity to attend cutting-edge lectures on international and theoretical economics. Delegates will appreciate our strong focus on global economic trends, international taxation, and Behavioural or Development Economics. This programme is the only extensive summer programme in Oxford that focuses on international economics. The following courses have been offered in International Economics in previous years:

### Global Macroeconomics

Students will gain a new perspective on the world economic dynamics and how the major economies of the world interact with each other and how their fiscal and monetary policies will affect the performance of the global economy.

### International Taxation

The course will introduce key concepts in taxation bringing an in-depth understanding of tax laws affecting international business and individuals

### Financial Crisis and Policy Responses

Students will learn the key concepts behind the banking systems and gain a better understanding of the measures taken by governments of many leading economies to tackle the financial crisis.

### Development Economics

The course will give an overview of policy-related issues faced by developing countries from both theoretical and applied perspectives.

### Behavioural Economics

This course introduces the approach and methods of behavioural economics. It will discuss some of the key findings of the literature and their applications in the real world.

### United Kingdom Corporate & Contract Law

This course will present important legal aspects of international mergers and acquisitions. As many international contacts are governed by UK, US, or Hong Kong law, it is important for students to learn about these aspects of Common Law.





## PHILOSOPHY, POLITICS, AND ECONOMICS

The programme will give all participants the opportunity to attend cutting-edge lectures on international and theoretical economics. Delegates will appreciate our strong focus on global economic trends, international taxation, and Behavioural or Development Economics. This programme is the only extensive summer programme in Oxford that focuses on PPE (Philosophy, Politics, and Economics). The following courses have been offered in PPE in previous years:

### Historic Political and Economic Philosophy

This course gives delegates an overview of historic philosophical schools. It covers aspects of ancient European philosophy with its origins in Athens and Rome as well as medieval thinking.

### Contemporary Political and Economic Philosophy

This course gives an insight into the modern philosophical thinking beginning with Machiavelli and the Enlightenment. Various philosophical schools and their viewpoints will be discussed.

### Legal Theory

This course focuses on the nature and importance of rules in legal systems and analyses some of the main difficulties associated with the implementation of laws, rules, and regulations.

### European Business Law

This course covers the main points of the European Union legal system and its interactions with member states' local laws in order to gain a perspective in Europe as a whole and its global influence.

### Development Economics

The course will give an overview of policy-related issues faced by developing countries from both theoretical and applied perspectives.

### Global Macroeconomics

Students will gain a new perspective on the world economic dynamics and how major global economies interact with each other and how their fiscal and monetary policies will affect the performance of the global economy.

*\*PPE students can also choose any course from the International Law or Economics tracks.*





## NATURAL SCIENCE

### Cosmology and Large-Scale Structure

The aim of this course is to present the most relevant theoretical and observational results on which modern cosmology are based. The course covers the basic mathematical framework of the standard cosmological model, its observational motivations and its most important shortcomings. At the end of the course students should be able to understand the main open questions in cosmology, as well as the current and future observational and computational tools used to tackle them.

### Theoretical Physics: Symmetries and Field Theories

This short course will focus on one of the primary guides to our understanding of modern day physics: symmetries. In particular, how symmetries can be used to construct gauge theories, the Higgs mechanism and gravity as a gauge theory. Topics covered include Symmetries and field theories, The Higgs mechanism and gravity as a gauge theory, Shift and Galilean symmetries in the early and late universe.

### Numerical Analysis

Differential equations are one of the most fundamental tools in almost all areas of science. The aim of this course is to give an introduction to the numerical solution of differential equations. Starting with the representation and approximation of functions (continuous objects) by vectors (discrete data), delegates discuss how the basic calculus tasks (differentiation, integration) are done on a computer and move on to solving differential equations. The course will be a combination of lectures and practical computing work.

### Image Processing & Surface Computing

**Image Processing:** Image processing uses mathematics to manipulate digital images like from a camera or a medical scanning device. The aim of this course is to give an introduction to diffusion PDEs as a means for image processing. Diffusion processes are used to remove noise while preserving or enhancing features such as edges which play an important role in the human perception of an image. In particular we will discuss edge-stopping, edge-enhancing, and coherence-enhancing diffusion models. Beyond that we will give an overview of other image processing tasks such as image inpainting and image deblurring which can be modelled with PDEs. The course will be a combination of lectures and practical computing work.

**Surface Computing:** This course introduces numerical solutions of Partial Differential Equations (PDEs) on surfaces using the Closest Point Method. Surface PDEs arise from many applications in physics, biology, and engineering. Among various numerical techniques for solving surface PDEs, the Closest Point Method is easy to implement and it works for a wide range of PDEs on surfaces with complex geometries. This course will cover basic theories, numerics and MATLAB implementations related to the method. On completion of the course, students can potentially solve interesting PDEs on intricate surfaces.



## ACADEMIC WRITING & ENGLISH LITERATURE

### Academic Writing & Critical Thinking

Students will learn how to identify and critique implicit claims in academic and journalistic writing, what characterises weak arguments and how to formulate strong ones, as well as how to interrogate visual arguments in video or photographic media. Students will also acquire more practical skills, including how to interpret essay questions, how to structure and reference an academic essay, as well as how to write with clarity, brevity and maximum impact.

### English Literature

This course will offer delegates a strong foundation for understanding the various facets of English Literature across eras and genres, tempering historical and ideological depth with attention to textual details. Prose, poetry, and drama will be considered in dynamic ways, inflected by engagement with various political, socio-economic, religious, philosophical, and cultural ideas.

### British Culture and History

The objective of this course is to provide students with an understanding of how English and British culture has developed over the ages. Why, for

instance, do we use the terms 'English' and 'British' interchangeably? How have they shaped each other conceptually? How has the notion of nationhood manifested itself in British art, literature, and culture in different eras? Each lecture will provide delegates with a strong historical and cultural foundation with which to approach literary texts, while also encouraging students to engage critically with questions of historiography.

### Intercultural Communication

This course will look at key academic and practical topics involved in intercultural communication. Drawing on the fields of literary studies, linguistics, anthropology, ethnography, and cultural studies, delegates will analyse topics including, 'Communicating between cultures', 'Translation', 'Verbal and Non-verbal Communication', and 'Cultures and Concepts'.

## BUSINESS & LEGAL ENGLISH

### Business English

This course will focus on the reading, writing, and listening skills of the English language in a business context. By being able to understand and use business language, participants have the possibility to further their careers in both their quality of work and build relationships among colleagues and clients.

### Legal English

This course will provide delegates with the ability to communicate at an international level using precise and correct legal language. Upon completion of the course, participants will improve their confidence in explaining points of law, enhance their drafting and editing skills, and ultimately represent their organisation in a more effective manner.

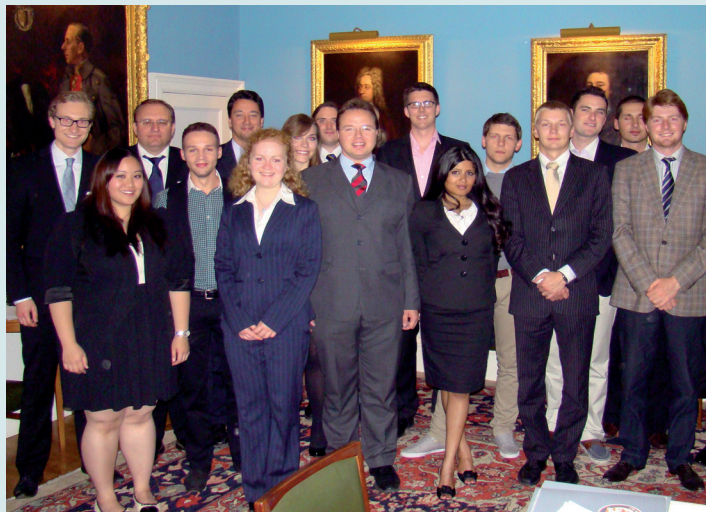
## CBL INTERNATIONAL 牛津奥利尔学院暑期培训项目简介



英国牛津大学是英语世界中历史最悠久的大学，成立于1167年，也是当今世界最顶尖的综合性大学之一。牛津大学由42个独立的学院组成。

奥利尔学院是于1326年由英国皇帝爱德华二世建立，是牛津大学历史最悠久的几个学院之一。至今学院全部的建筑均保持数百年前的真实原貌。

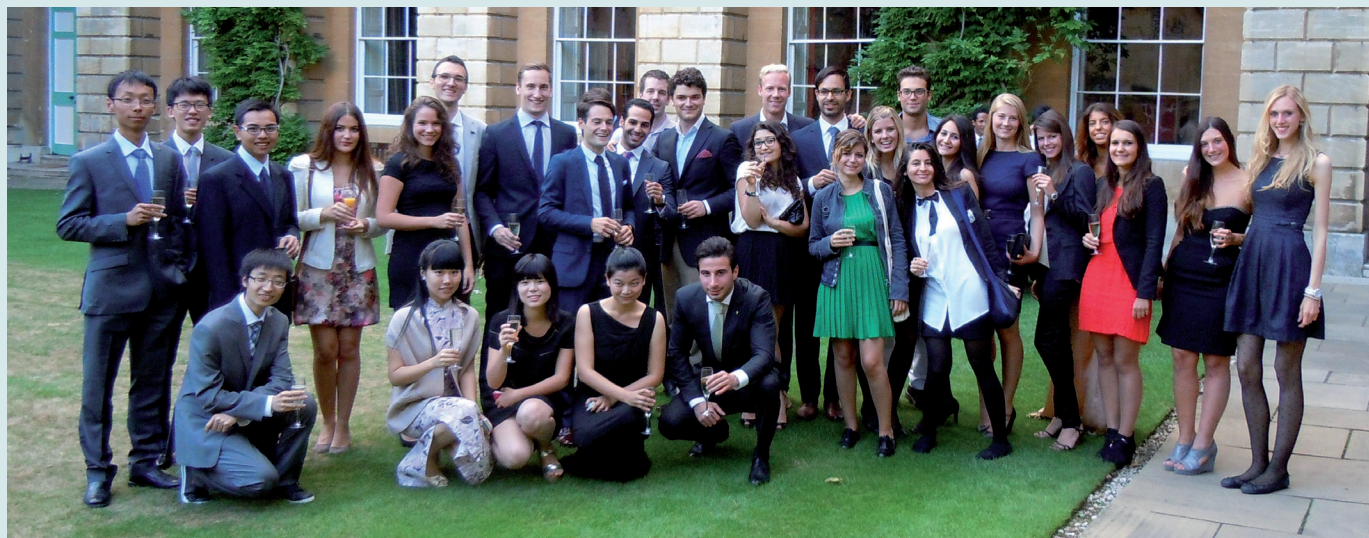
